Government Update

FURTHER STEPS TO CURB PHOSPHORUS, FACILITATE ENHANCED SCIENCE AMONG NEXT STEPS IN ACTION ON LAKE WINNIPEG

Province has Started Action on 84 per cent of Recommendations, Lake Stewardship Board Report Provides Clear Blueprint for Action: Melnick

Water Stewardship Minister Christine Melnick today released the Lake Winnipeg Stewardship Board's final report and announced the next new steps in reducing nutrients in the lake.

"This report clearly shows Manitoba is on the right track in its plan to improve the condition of Lake Winnipeg, as we have already initiated action on 84 per cent of the recommendations, "the minister said. "I would to like thank the board members for their hard work. This report provides governments, businesses and individuals with a clear blueprint that will help us further face our collective responsibility to fix a problem that was decades in the making."

The minister accepted in principle all 135 recommendations in the report, noting the province has already acted on or initiated action on 113 of the recommendations.

"The recommendations in this report are far-reaching, crossing every sector of society, and present a plan for action. Now is the time for all of us to accept our collective responsibility and to support the province's commitment to action for the benefit of Lake Winnipeg, "said Bill Barlow, chair of the Lake Winnipeg Stewardship Board.

Melnick announced immediate next steps on priority areas outlined by the Lake Winnipeg Stewardship Board. These include:

A renewed, robust commitment to infrastructure investments. The province will negotiate predictable funding agreements with municipal and federal governments on wastewater infrastructure, building on the \$100 million the province already invested in water-quality projects around the province since 1999 with a focus on support for the costs of meeting stronger environmental standards.

An expanded mandate for the board. The Lake Winnipeg Stewardship Board's mandate has been expanded to advising government on matters such as water pollution and fisheries issues. As well, the board will periodically report to the minister on the state of the lake.

New investments in research and shared science. The Manitoba government will make new investments in scientific research on Lake Winnipeg and its watershed including funding for the ship Namao as a research and education platform. In addition, a committee of scientists will be formed to share information and improve co-ordination of research on the lake.

Restrictions on phosphorus. This spring, the province will be introducing limits on fertilizer and municipal sludge application on agricultural lands and golf courses as part of its nutrient management regulation and will prohibit all nutrient applications in buffers zones along water bodies. Currently these restrictions only apply to manure application. These restrictions will apply immediately for new developments. For existing properties in sensitive areas, they will come into effect in 2009. For remaining parts of the province, they will be in effect in 2011.

A cross-government action team. A new team of government representatives will be assembled to spearhead action and co-operation on improving lake quality.

Initiation of public education, consultations on cosmetic fertilizers and other household products. Manitoba Water Stewardship will engage the public and stakeholders about the harmful impact on Lake Winnipeg of products that contain phosphorus and will seek public advice on ways to find alternatives to their use.

Melnick said actions announced today build on the Manitoba government's ongoing efforts since 1999 to improve water quality and protect this valuable resource.

"This government has worked very hard and diligently to ensure that Lake Winnipeg and all of the waterways in our province are protected. Some of our many initiatives include creating the very first department of water stewardship in Canada, passing the first-of-its kind Water Protection Act and investing more than \$100 million toward water-quality projects in Manitoba. We have also committed to public education on the harmful effects on water quality that result from cosmetic fertilizers and other household products containing phosphorus," said Melnick.

The Lake Winnipeg Stewardship Board was formed in 2003 as part of the Lake Winnipeg Action Plan. The board comprises 17 members with representatives from a variety of interests and sectors including municipalities, First Nations, commercial fishing, science and agriculture.

"Again, I would like to thank the board for their efforts in producing this very technical and complex report which will help us bring Lake Winnipeg's nutrient status to its pre-1970's conditions. We in Manitoba know that clean water is the gold of this century and by respectfully handling this resource, the 21st century will belong to us. It is imperative that everyone in the province take part in protecting and preserving our tremendous resource for future generations," concluded Melnick.



"Brochet, MB. and Beyond"

Brochet once had a priest that relentlessly tended to several community gardens, promoting community wellness, creating local accessibility to healthy foods and beautified the entire area. Still today the mission ground is well nourished from past tender loving care, and awaits future nourishment.

The Northern Healthy Foods project continues to grow, pun intended. Brochet, one of the most remote communities in Manitoba will be demonstrating a greenhouse project, in collaboration with Frontier School Division, Brochet Community Council, Manitoba Aboriginal and Northern Affairs, Northern Healthy Foods Initiative, led by NACC.

The project was prompted for several reasons, based on the interest of the community.

Projects such as these can incorporate an array of positive outcomes, such as:

- 1) Connects youth with nature
- 2) Connects community members with school
- 3) The greenhouse will incorporate a more hands on and healthier school curriculum
- 4) The Greenhouse can produce up to 1000 vegetables, of the communities choice
- 5) Promotes community beautification
- 6) Aids new gardeners, and supports intermediate green thumbs
- 7) Encourages food localism and sustainable food systems
- 8) Presents economic development opportunity
- 9) Encourages waste management such as composting
- 10) Promotes food preservation
- 11) Potentially reduces grocery bills!!!!!!

Steps of the project include:

- 1) Student germinating plants for greenhouse as part of school curriculum
- 2) Building modest Greenhouse at the school;
- 3) Transplanting germinated vegetables into greenhouse
- Sharing germinated vegetables and flowers from greenhouse once school is out for summer
- 5) Transplanting flowers and vegetables in individual and community gardens
- 6) Maintaining the gardens and enjoying the vegetables
- 7) Preserve left over veggies

This project encompasses several aspects of community wellness, such as instilling pride with community youth, developing healthy eating habits, increasing physical activity, reducing diabetes and increasing connection of man and nature.....

WATER STEWARDSHIP MINISTER ANNOUNCES LONG SERVICE FISHER AWARD Nominations Sought to Honour Commercial Fishers: Melnick

To recognize the long-term contributions of Manitobans to the province's commercial fishing industry, Water Stewardship Minister Christine Melnick today announced the introduction of Manitoba's Long Service Fisher Award. Commercial fishing is critical to the local economies of many of the province's northern communities and is a major contributor to Manitoba's overall economy, paying out more than \$30 million annually to commercial fishers. The Freshwater Fish Marketing Corporation, which processes and markets fish on behalf of fishers, has annual sales averaging \$60 million. Freshwater fish harvested in Manitoba is considered to be of exceptional quality and is sought in markets throughout the world.

"It is a pleasure to announce with the Manitoba Commercial Inland Fishers Federation (MCIFF) the introduction of the Long Service Fisher Award," said Melnick.

Presentation of the Long Service Fisher Awards will take place at a dinner hosted by Melnick at the MCIFF's annual general meeting on April 11 in Portage la Prairie. The MCIFF will assist Manitoba Water Stewardship in seeking nominations of fishers who qualify for the award.

All Manitobans with 50 years or more of commercial fishing experience are eligible to receive the new Long Service Fisher Award. Fishers can self-nominate or be nominated by others. Nominations are due March 28 and nomination forms will be available online at

<u>http://www.gov.mb.ca/waterstewardship</u> or from the MCIFF.

In conjunction with the Long Service Fisher Award, the MCIFF, in partnership with the minister, has also established an Exceptional Contribution Award to recognize fishers from the federation's various regions.

Manitoba's fishing industry includes more than 3,200 commercially licensed fishers and their hired helpers, the vast majority of whom are of Aboriginal or Métis descent.

"Manitobans who have worked in the fishing industry over the years have created a colourful history, developed strong community ties and built an industry that is an important piece of the province's economy," said Education, Citizenship and Youth Minister Peter Bjornson.



Good-bye, Manitoba Winter

Snow and ice are two of the necessary evils that are associated with saying good-bye to a Manitoba winter. They build up on everything, and this creates more work for some, or just simply makes work harder for others.

Outdoor natural gas and/or pressure regulator sets are designed to withstand extreme weather, but remember to protect them from ice and snow buildup. Clean and repair leaky eaves troughs to prevent ice and melting snow from dripping onto the meter causing it to be encased in ice. Don't pile snow against your natural gas meter when shoveling or blowing snow. Remove soft snow buildup gently, using only a broom or your hand. Call 480-5900 or 1 888 MB HYDRO (1-888-624-9376), if you notice ice buildup on any part of the natural gas meter. Do not try to remove it by kicking or hitting the gas meter or piping.

Ice also builds up on power lines, which may cause them to break, or the poles to snap or crumple under the weight in a matter of hours. So, the ice must be removed as quickly as possible by Manitoba Hydro employees to ensure against power outages and equipment damages. If you notice an excessive build up of ice on a certain section of lines, call 480-5900 or 1 888 MB HYDRO.

In order to keep yourself and your family safe, always stay clear of low or sagging lines. Travel under or near them can be dangerous. Immediately report downed wires to Manitoba Hydro or to the police, and treat all downed wires as if they are energized and stay clear of them. Make sure that children don't go anywhere near them, and keep pets inside to ensure their safety. You should never attempt to repair lines or remove tree limbs from lines.

If you see crews working on ice laden lines in your community, try to avoid traveling near their work area.

In the case of a prolonged power outage, stay tuned to your local radio station for regular updates on the progress of the restoration efforts.

Manitoba Hydro invites submissions to 2007 Spirit of the Earth Awards

Spirit of the Earth Awards promotes environmental awareness while recognizing the culture and history of Aboriginal people. The annual Awards program is open to any individual or group whose environmental activity has been implemented by Aboriginal people, or non-Aboriginal people working with Aboriginal communities.

The deadline for submissions is April 27, 2007.

Spirit of the Earth Award recipients will be honoured on National Aboriginal Day, June 21, 2007 in OCN/The Pas, Manitoba.

Criteria Submission must:



Simple Southern Style "Un-fried" Chicken

Prep Time: 15 min. Ready In: 1 hr. 30 min.
Serves: 6
1 Whole Chicken (about 3 lb.) cut-up
1/3 cup Kraft Calorie-Wise Rancher's Choice

Dressing

1 pouch Shaken Bake Extra Crispy Original Coating Mix
