Colleen speaks to the importance of communities uniting and including all on communication as there is power in everybody knowing that everybody is on the same page regarding issues they wish addressed.

Tim Johnston from Communities Futures. Darlene the longest serving Board Member and also thanks to Jim Chornoby. Gillum to Swan River is now connected by snow sled trails.

# 6.0 **COMMUNITY REPORTS**

Pelican Rapids – Janet Genaille – The community hall burnt down from grass fire.

Moose Lake — Caroline Campbell— Noted the lack of INR staff as they were hoping to meet them at the conference and they are not present from the Thompson office. Would like the Board to know that their budget is bad. Their roads are in terrible condition and they cannot afford to deal with it. Where do they go now that the INR no longer has extra funding to assist them in such maintenance. They have had their fire truck for 25 years and it was used when they got it. They were supposed to get one last year but it went to another community. Want the NACC to lobby more on their behalf. They got funds for dust control but they have no gravel so why would they need dust control. RCMP even got stuck on the road. It is a safety issue. Kids on busses, ambulance, etc. Approx. 8km of road requires maintenance. Their BBQ on Canada Day went very well and everybody was involved. They hired 18 summer students. Elections are coming up.

Cross Lake, Ila McIvor – Finished park which now has a stage, playground, concession, and bathroom. Their Cadet program saw 25 youth at summer training. They have submitted and received some capital funds from feds as they do not get anything from provincial government. Housing is still an issue. Cowessess First Nation still wants to take it over. Working on personal care home for 30 beds. Just completed a new nix station by council working with others. Fixing government assets with no support from INR. Lagoon road is completed. Had 17<sup>th</sup> Annual Family Camp with over 1000 campers for one week. Hired 20 summer students. Darlene Beck thanks for funding funds.

Norway House, Leonard Budd - we are in survival mode - had issues with infrastructure - water plant, need for furnaces for arena running about \$15,000 for 3 - need shingles. No funds to cover. As mentioned from other communities but now the conservatives were elected and program was under review and have not seen funds since. Hoping to take advantage of Federal Infrastructure program at breakout session. They met with Minister in May and discussed acting deputy minister that there is suppose to be a capital program this year. Want to hear about the changes to the program. That the department review in all communities the needs. Staffing is an issue as well. They are to work in partnership with INR and they used to communicate with staff but since the new government there has been little or no communication with INR staff. Technical public works consultant was assigned to all communities but in their region, they do not have one. Their community has had to deal with infrastructure and they are in debt because of it. In two cases they had commitments from INR staff in Thompson to fix and that they were never reimbursed. Working on community settlement agreement. The funds from Manitoba Hydro is not to be used for programs in place and INR asks that they spend it. They purchased a backhoe and did church upgrades. Their core funding from INR is late as well. They received their second quarter at the end of July. Historically it was received in April. Municipal funds used to be received in January of the current year and in the last couple of years they have been getting later and later. Now at the end of July. When dealing with Audits, they are waiting for confirmation of funds from INR thereby delaying audits. It was not until Lloyd spoke with Paul Doolan at INR did any paper move. Asked the minister if the Thompson INR was going to dissolve and the minister said no it would not be but the jobs are still posted to be filled. Water is being delivered. Concerned about capital program threatens to revert to life in the 70's with water in pails and slop in pails. Encourages all communities to request a meeting with the minister to be heard. Priority for Norway is safe water, garbage pickup and sewer pumped out. They have been assisting the neighbouring first nations community with fire safety and water. Paul Doolan has noted that he plans to get the regional meetings happening again.

Easterville, Garfield McKay — same issues as Moose Lake with roads — they need gravel and culverts. They have requested. They do not have a sewage truck and pay for each pump out. Autopack notes a payment is sitting at the Thompson office for the sewage truck accident and they have not received the funds. The sewage backups are a health issue.

WHEREAS: The Manitoba Hydro rate exemption creates an inequity between both Communities.

THEREFORE, BE IT RESOLVED: That NACC meet with the Manitoba Hydro Board and request that all residents of Manitoba Indigenous & Northern Relations communities adjacent to First Nation communities be also exempt from the Manitoba Hydro rate increases.

### Resolution#009.19. N

WHEREAS: Costs to provide basic municipal services continue to increase.

WHEREAS: The Manitoba Indigenous & Northern Relations has not provided an increase to offset inflationary increases.

THEREFORE, BE IT RESOLVED: That NACC meet with Manitoba Indigenous & Northern Relations Officials and request communities receive an increase in funding to offset cost increases resulting from inflation.

WHEREAS: The meal and per kilometer travel rates set by the Manitoba Indigenous & Northern Relations are low.

WHEREAS: The cost for meals and fuel has increased.

THEREFORE, BE IT RESOLVED: That NACC meet with Manitoba Indigenous & Northern Relations Officials and request that the meal and per kilometer travel rates be increased

WHEREAS: A Community members sewage pump is not working due to electrical issues, electricity not working from the house to pump and keeps tripping panel box when turned on.

THEREFORE, BE IT RESOLVED: That God's Lake Narrows Community Council is requesting NACC for assistance by lobbying Manitoba Housing to visit God's Lake Narrows Community and inspect all homes needing repairs and electrical issues requiring fixing.

WHEREAS: The Councils has had a specials meeting July 17th, 2019 regarding the local roads which are in dangerous condition and in need of serious attention. Our roads are being utilized by the school buses, medical buses, water, sewer, garbage trucks, and the Gardewine semi's drive by to deliver the groceries and other retails to the Northern Store. Gas and diesel are also being delivered to the Northern store and damaging the roads more every time they drive in and out of the road. \$16,000.00 is being funded to the Moose Lake Community Council a year and this is a problem for the council as this in not enough to fix roads. The Community Council only has one back hoe and it causes problems as there is always something wrong with the machine. Pictures are sent with the proposal to NACC. The council is also asking for the roads to be paved.

THEREFORE, BE IT RESOLVED: This will be presented at the NACC conference in Winnipeg with the Mayor and Council.

WHEREAS: This situation will continue to exist for the foreseeable future.

THEREFORE, BE IT RESOLVED: That Brochet community council request NACC to lobby the Provincial and Federal Government to provide the residents of Brochet with a ferry service on Reindeer Lake linking to Provincial Road 394.
