- Own community, in the process of having 2 cottage subdivision within boundary. Permanent residence of cottage association. With the number of cottage association outnumber, could lead to positive outcomes. 28 from community attended meeting to vote where 24 voted yes.

  - Watership district area meeting

- Trappers training section, received lots of support for NACC to make it happened with 22 participants attending the training.
- Water system break down in community which fixed at a managed cost. Northern Affairs has no record of the system. Would like to remind other township may have water system built at about the same time which may have similar issue. In waterhen, the system is falling about, lost 100,000 gallons of water and spent 7,000 to have the system fixed in 2 hours.

- Rocky Lake called with garbage dump issue where Rocky Lake is not NACC but INR look after them. Unfortunate NACC cannot do anything for them. Teamed up with MKO, if you have a large indigenous base in community, they offer services, where Sherridon got brand new snow suits from MKO funding for kids. Happy to share contacts of MKO to other Board members.
